## OUR HISTORY & MISSION

An independent, private, non-profit law school accredited by both the American Bar Association and the Higher Learning Commission, Cooley delivers a year-round legal education across its campuses in Michigan and Florida. This flexible structure reflects the institution's commitment to meeting students where they are, providing multiple pathways to pursue a legal education while balancing personal and professional responsibilities.

At its core, Cooley's mission is to prepare graduates for the practical realities of the legal profession. The school emphasizes a rigorous, hands-on education that develops critical thinking, clear communication, and professional confidence. Through a curriculum that integrates doctrinal learning with experiential opportunities, students gain the skills needed not only to succeed on the bar exam, but to thrive in practice. As reflected in ongoing curriculum evolution, Cooley continues to prioritize experiential learning, legal writing, and flexibility so students are equipped to adapt in a changing legal landscape.

Equally important is Cooley's commitment to community. The institution fosters a diverse, inclusive, and collaborative environment where students are supported as individuals and encouraged to grow into future-ready professionals. With a network of more than 21,000 alumni, Cooley extends its mission beyond the classroom—preparing graduates to serve clients, contribute to the profession, and navigate complex legal challenges with confidence and purpose.

## ACADEMIC HONORS

**Honor Roll.** Students who achieve a cumulative grade point average of at least 3.0 in any semester in which they earned at least 4 credit hours will be placed on the Honor Roll.

**Dean's List.** Students who completed at least six credit hours in a single semester and earned a grade point average for that semester of 3.0 will be placed on the Dean's List for that semester.

**Summa Cum Laude.** The graduation candidate with the highest cumulative grade point average of 3.5 or above will be awarded their degree *summa cum laude*.

**Magna Cum Laude.** Other graduation candidates with cumulative grade point average of 3.5 or above will be awarded their degrees *magna cum laude*.

**Cum Laude.** Graduation candidates with a cumulative grade point average of 3.0 or above and less than 3.5 will be awarded their degrees *cum laude*.

**With Distinction.** If the graduates in the above classes of honors do not total 25% of the graduating class, then the remaining candidates in the top 25% of the graduating class will be awarded their degrees with distinction.

## Commencement Speaker

Jeffrey D. Swartz  
Distinguished Professor Emeritus, Cooley Law School

Professor Swartz is a graduate of The Ohio State University and in 1976, was member of the first graduating class of Thomas M. Cooley Law School. He joined the faculty at Cooley Law School in 2012. He had been a practicing attorney since 1976 (50 years) in Ohio, Florida, and Colorado. Professor Swartz has also been admitted to several Federal Districts, three Federal Circuits and The United States Supreme Court Bar.

Professor Swartz has participated in appeals and oral arguments before the Ohio Supreme, the Florida Supreme Court, the U.S. Court of Appeals for the 11th Circuit and the First, Third and Fourth District Courts of Appeal of Florida.

After several years as a prosecutor in Ohio and as Assistant State Attorney for the 11th Judicial Circuit of Florida (Miami-Dade County), Professor Swartz entered private practice as a criminal defense attorney. In 1994 Professor Swartz was elected to serve as a County Court Judge in Miami-Dade County. He served in that capacity until 2005.

Prior to joining Cooley, Professor Swartz served as senior trial counsel in commercial litigation, criminal defense and appellate counsel for Rosenthal, Rosenthal Rasco Kaplan, LLC, (2009-2012). He was previously a partner with Stephens, Lynn, Klein, LaCava, and Puya, P.A., where he practiced in the areas of professional malpractice defense, commercial litigation, criminal defense insurance coverage litigation, and attorney fee litigation. Professor Swartz has appeared as an expert witness on standard of care for attorneys and attorney fee issues.

While serving as a County Court Judge, Professor Swartz served as a member of the faculty of the Conference of County Court Judges, as well as for the faculty of the Florida College of Advanced Judicial Studies. He also served three terms as a member and chair of the Florida Supreme Court Judicial Ethics Advisory Committee (1998-2004). Professor Swartz just completed a six-year term on the Florida Bar's Permanent Committees on the Rules of Traffic Court and Rules of Criminal Procedure.

At Cooley, Professor Swartz teaches Criminal Law and Criminal Procedure. He has made numerous appearances on national, local television and international radio and television providing expert commentary. For a two year period he and Professor Brendan Beery hosted a blog-talk radio program, every Tuesday at 10 a.m.
